



GAME RULES

“25 YEARS - SHARE THE MEMORIES”

ORGANISED BY THE AIR TAHITI NUI COMPANY TO CELEBRATE 25 YEARS OF AIR TAHITI NUI.

Article 1 - Purpose

AIR TAHITI NUI, a Société Anonyme d'Economie Mixte Locale (semi-public local company) with capital of 1,622,956,875 XPF, with its registered office at Tahiti-Faa'a Airport, Immeuble Tua rata- Faa'a, BP 60044 - 98 702, registered in the Papeete Trade and Companies Register under the numbers RC 96217 B - N° Tahiti 382192, represented by Kareen SABONNADIÈRE, Loyalty Club Tiare & Partnerships Manager, is organising a free competition 1st October to 31st October 2023 with no purchase necessary and with the winners being announced on the last day of each month called: “25 years “Share The Memories” with club Tiare and partners” under the terms and conditions set out in these rules.

This game is not affiliated with, managed, sponsored or endorsed by Facebook.

Article 2 - Terms of participation

Participation in this free game is open to current members of the Club Tiare programme, excluding Air Tahiti Nui employees and their relatives. No purchase is necessary. Participation is strictly nominative and the entrant may not under any circumstances play on behalf of other entrants.

Only one entry is permitted per person with the same surname, first name and e-mail address, throughout the entire duration of the game. All entrants authorise Air Tahiti Nui to verify their identity.

All entries must be made in good faith. Air Tahiti Nui is committed to ensuring equal chances and reserves the right to exclude any potentially fraudulent entrants.

Article 3 - How the game works

The game is played exclusively with no purchase necessary. During the period from 1st October to 31st October 2023, current members of the programme will be able to play to win 25,000 Miles each month.

To take part in the game and be eligible for the draw, entrants must share a story about their favourite Air Tahiti Nui memory over the last 25 years either on social media quoting #AirTahitiNuiMemories or by sending an email to animation.clubtiare@airtahitinui.pf. When entering via social media, entrants will be asked to confirm their identity to ensure that they are current members of Club Tiare.

The draw will take place 6th November 2023 to select one winner for the period of 1st October to 31st October 2023:

Entrants whose names are not drawn will be automatically entered into the draw to be held the following month.

Taking part in the game subject to these rules constitutes permission for the company to use the entrant's story in anonymised form.

The Loyalty department will send a special newsletter to the entire Club Tiare database across its network to invite current Club Tiare members to take part in the game.



BONUS : all participants in the games Share the Love and Share the Memories from April 2023 to October the 31th will be automatically registered to draw lot Grand Tirage on 20th November 2023 to enter the drawing to win 250 000 miles.

Article 4 - Announcement of winners

Winners will be notified by email or telephone.

A valid email address and telephone number will be requested in order to continue e-mail communication with animation.clubtiare@airtahitinui.pf. Winners will be required to attend the Air Tahiti Nui head office at the TUA RATA building located at Tahiti Faa'a airport to collect their prize.

If the winners fail to respond within three days of the winners' list being published, their prizes will be forfeited automatically.

In accordance with Article 9 of the French Civil Code, prior to any use of the winners' image rights in its advertising and promotional material, Air Tahiti Nui must obtain the winners' express permission to use their first and last names and their image on the Air Tahiti Nui website, without this granting the winners any right to remuneration or any advantage whatsoever, other than the prize.

Article 5 - The prizes

The draw on 6th November : a prize of 25,000 Miles worth 75,000 XPF;

Prizes cannot be exchanged for cash or monetary equivalent.

The bonus prize will be allocated throughout the draw of Grand Tirage on 20th November. The total value is 750 000 F CFP. This prize is common to Share the Love and Share the Memories games.

Prizes are not transferable and may not be awarded in any other form than as provided for in these rules.

Prizes are not returnable and cannot be exchanged for any other goods or services.

Article 6 - Modification of the game

Air Tahiti Nui reserves the right to modify, extend, curtail or completely cancel the game in exceptional circumstances or in the event of force majeure.

Article 7 - Terms of use of prizes

1 prize + 1 bonus prize to be won over the period.

Prizes are in the name of the winner, are non-transferable and cannot be exchanged for any monetary value.

Article 8 - Liability

Air Tahiti Nui cannot be held responsible for any damage of any nature whatsoever caused to entrants and/or winners both during the game and during the use of the prizes, other than its usual liability as an airline.

Air Tahiti Nui cannot be held responsible in the event of force majeure as defined by legal precedent or in the event of exceptional circumstances beyond its control.

Air Tahiti Nui cannot be held responsible and no action can be taken against it due to events of force majeure (strikes, bad weather, etc.) that deprive entrants in whole or in part of the opportunity to participate in the game and/or that prevent the winners from claiming or using their prize.



Air Tahiti Nui and its service providers and partners shall under no circumstances be held responsible for any incidents that may occur during the use of the prizes by the winners or their guests once they have been awarded.

Air Tahiti Nui, its service providers and partners cannot be held responsible for the loss or theft of the prizes once they have been awarded. ARTICLE 9 - Protection of personal data

Air Tahiti Nui undertakes to comply with the French Data Protection Act no. 78-17 of 6 January 1978 and with all other applicable regulations, including EU Regulation 2016/679 of the European Parliament and of the Council of 27 April 2016 on personal data protection and the free movement of such data, in respect of processing entrants' personal data in connection with the game.

The personal data collected in connection with the game, as well as that subsequently collected or generated, is to be used for the purposes of managing the game.

It may be disclosed for management purposes to duly authorised subcontractors, service providers and partners, brokers and insurers, to the extent required to carry out the tasks entrusted to them.

Entrants have the right to access their personal data, as well as the right to have inaccurate or out of date data corrected or deleted, or to object to the data being processed, subject to providing a legitimate reason. Article 10 - Game rules

The game is organised by Air Tahiti Nui, a semi-public company (SAEML) whose head office is located at Tahiti Faa'a Airport, Immeuble Tua Rata, BP 60044 - 98 702 Faa'a.

These rules apply to the draw to determine the winners of the "25 years - Share the memories" game, which will take place on November 6th 2023 and 20th November or the next working day, from midday.

The rules are subject to the legislation applicable in French Polynesia.

Taking part in the game constitutes acceptance of all of the provisions of these rules in their entirety.

The cost of posting a request for the rules (rate based on the postal service's rate for low speed delivery at a weight of 20g) may be reimbursed to any person who requests it before November 15th 2023 (date: the postmark of the postal service being taken as proof of the date of the request) and includes bank account details up to a limit of one reimbursement per "household" (same surname, same address).



The rules may be amended at any time in the form of an addendum by Air Tahiti Nui, in accordance with the above conditions, and published on the Air Tahiti Nui website www.airtahitinui.com, and lodged with court official Mr. Gérard LeHartel, rue Tepano Jaussen - BP 2060 - 98713 Papeete, who holds the rules prior to their publication. Such addendum shall come into force as soon as it is posted online and any entrant shall be deemed to have accepted it merely by participating in the game, from the date on which the amendment takes effect. Any entrant who refuses to accept the amendment(s) shall no longer participate in the game.

Article 11 - Disputes

Any fraud or attempted fraud by a player in this game will result in the player being disqualified. Any dispute arising in connection with this game must be submitted in writing within a maximum period of twenty (20) days from the date the winners are announced.

Air Tahiti Nui shall be the final arbiter of any matter relating to the application of these rules or any matter that may arise that is not covered by these rules.

Disputes will be subject to the jurisdiction of the French Polynesian courts.
